





On July 21, 2006 my house was destroyed by a lightning strike which caused severe fire, smoke and water damage. On July 23 I was notified that my insurance company had declared bankruptcy. This left me with many problems not the least of which was the extraordinary delay in obtaining payment on my claim due to the fact that the claim had to be moved from Alabama and Texas to New York State, which stepped in as the insurer of last resort. The house had to be reduced to stud and rebuilt. The process had to be started without available funds as the frustrating bureaucratic process went through its many steps.

Champion Adjustment Company, my adjusters, placed us in contact with M.
